Defendant is prohibited from accessing any child exploitation material and any other sexually explicit material through the Internet or by any other means. Defendant prohibited from contacting a minor over the internet or using a website to gather information about a minor. Defendant is prohibited from intentionally deleting any history from any computer or device that accesses the Internet. Defendant to be released during regular business hours only and is to report directly to Wisconsin Community Services upon release. Defendant to comply with GPS monitoring through Wisconsin Community Services. Defendant is not to come within 1.5 mile of home of Victim A, B and C as well as the school that Victim A attends. Defendant to pay costs associated with GPS. Defendant is not to possess any dangerous weapons/firearms. If DNA sample has not been taken from the defendant, the Court orders sample to be taken; and it may be expunged under 165.77(4) Wis. Statutes.</p>
